PART A - INTRODUCTION

1. Background to the institution

The European School of Animal Osteopathy (the School and ESAO) was established in 1993. Teaching commenced in the United Kingdom (UK) in 1998. The main school is located in Liseaux, Normandy, which has stabling and pastures.

The School, which is the subject of this inspection, is based in the centre of Hove. During the last few months, the school has reduced the size of its premises. A classroom, together with a dissecting laboratory, is provided at the School and practical sessions are held in several equine sites, within proximity to Brighton. These sites are provided by mutual arrangement with the sites' owners, whereby ESAO provides osteopathy for the horses, in return for using the facilities.

Students come mainly from France. However, plans have now been actioned to attract students from the UK and Ireland. At the present time, the School is limited to European Union (EU) students only as it does not wish to become involved in visa issues. Students come from a range of sectors, with a number coming from a veterinary background and wanting the broader experience to supplement their practice. It is understood that recently student numbers have decreased in the Brighton School, which is why the School has the necessary capacity to raise its recruitment drive in the UK.

Students attend a three or five-year course, which is aimed to be equivalent to Bachelor of Arts and Master of Arts degrees respectively. The provision includes practical placements and training sessions.

Students come mainly from France, with a number coming from a veterinary background and wanting broader experience to supplement their practice.

2. Brief description of the current provision

All students attend a three or five-year course. The provision includes practical sessions. The foreign students also study for, and take, the Cambridge English First (FCE) and Cambridge English Advanced (CAE) examinations in the English Language. The teaching is delivered in both English and French.

There are approximately five work placements per year, with opportunities to create a reflective assignment of the experience. Students spend approximately 15 hours per week learning English and a similar period in animal osteopathy. The tutorials include classroom teaching and work in the dissecting laboratory. There is a computer suite for self-directed learning. The teaching staff are a combination of clinical practitioners and teaching professionals.

The clinically qualified staff mostly run a practice outside the school, which the students value as they consider it helps the staff to be current and up to date in their knowledge.

The school relocated in September 2016, from Brighton to Hove. Teaching is now carried out during one week per month and an element of online blended and distance learning has been introduced to the core modules.

The foreign students take the FCE and CAE Cambridge examinations in the English Language. Teaching is delivered in both English and French.

ESAO are currently directing its marketing strategy towards British and Irish students.

3. Inspection process

The inspection visit was undertaken by a single inspector. Discussions were held with the Head of School, the Deputy and the Personal Assistant. The inspector was shown around the new school premises.
