DEADLINE FOR IMPLEMENTATION OF TIER 4 APPROACHES

THE HOME OFFICE HAS SET THE FOLLOWING DEADLINES FOR THE implementation of Tier 4 of the Points-Based System:

2nd February 2009 – applications for a UKBA licence received after this date are not guaranteed to be processed in time for the implementation of Tier 4 at the end of March.

March 2009 – from the end of March 2009 international students applying to study in the UK will be assessed under the new points system. Institutions which are not on the Register of Sponsors will find that prospective students' visas are refused and current students' visas are not renewed.

BAC is working at full capacity in order to process as many applications as possible by the February deadline; for institutions considering accreditation this is the last chance to become accredited in time for the implementation of Tier 4. Please contact us with any queries over accreditation or applications to the Register of Sponsors and we will do our best to keep you informed over the coming months.

ACCREDITED INSTITUTION PROFILE: London College of Accountancy

EIGHT YEARS AGO, THE LONDON COLLEGE of Accountancy opened with only about 250 students; now it has over 4000, and has won the Queen's Award for Enterprise in International Trade. This success has been achieved largely through word of mouth: during the most recent BAC visit, inspectors were able to meet a group of LCA students, and learnt that most of them had joined the college through a recommendation from a friend or family member. Behind the success of LCA is the Founder and Managing Director, Mr Ravi Gill, who has built a reputation for high quality teaching at an affordable cost.

The vast majority of students at LCA are studying for ACCA (Association of Chartered Certified Accountants) qualifications, but the college also offers a range of undergraduate and postgraduate courses from Anglia Ruskin University such as an International MBA, an MSc in International Accounting and a Postgraduate Diploma and Certificate in Business Administration. There is also the option for ACCA students to top up their qualifications by way of a 5000-word project to gain the BSc in Applied Accountancy from Oxford Brookes University. Soon after the college was established it gained 'Platinum' status from ACCA for its successful examination results, and has since enjoyed a reputation for delivering high-quality ACCA programmes.

Another key factor in the success of LCA is the comfortable relationship the students enjoy with members of teaching and administrative staff. At the last BAC inspection, the students said they could make easy, informal contact with members of the senior management team, and also praised both the quality of teaching and the speed with which feedback was received. The reporting inspector

noted that all members of the teaching and academic staff saw themselves as playing a part in the general welfare of students at the college; besides this, staff turnover is very low at LCA, which helps to keep things stable, so that students feel more relaxed and able to focus on their work.

The London College of Accountancy received the Queen's Award for Enterprise in International Trade in 2006 after the rapid growth in student numbers from over 100 different countries. In a comment on the LCA website, Gill describes how the college achieved this growth in such a short time by making exam success a top priority: "We have grown so rapidly by attracting the best quality lecturers and by giving our students access to the best tuition in a supportive environment at affordable prices". By putting academic quality first, the London College of Accountancy has ensured its success, and has remained a popular choice for students from all over the world.

Health and Safety at Work

A YOUNG PERSON IS SERIOUSLY INJURED in a UK workplace every 40 minutes. In the last decade, 66 under-19s have been killed at work. These stark statistics show why it is vital for colleges to have a "competent person" to advise the management on matters of health and safety. The best solution is for a college to put a senior member of staff through NEBOSH's National General Certificate in

Occupational Safety and Health, which is the global standard for low-risk environments such as colleges. This qualification, accredited by QCA at Level 3, takes 10-12 days of study and can be taken at over 400 places in the UK and in many other countries. Details can be found at www.nebosh.org.uk.

You may also want to offer your students a chance to study, free of charge, for the British Safety Council's Entry Level Award in Workplace Hazard Awareness or its Level 1 Certificate in Health and Safety at Work. Both fit neatly into work-related learning programmes and provide a formal assessment outcome to the delivery of health and safety, as well as contributing to college performance figures. Both qualifications are supported by free learning materials. To date, over 1,500 schools and colleges have registered for these qualifications. HANSARD SOCIETY FIRST ACCREDITED INSTITUTION ON REGISTER OF SPONSORS

THE HANSARD SOCIETY, WHICH IS BAC-accredited for its Hansard Scholars Programme, is now on the Home Office's Register of Sponsors for overseas students, making it the first accredited institution to be listed.

The Register, which lists those institutions that are allowed to sponsor overseas students or workers to enter the UK, is run by the UK Border Agency (UKBA), part of the Home Office. The Hansard Society was one of the first organisations to apply, and is now registered as a sponsor under Tier 4, meaning that it is licensed to enrol students from outside Europe.

The Hansard Scholars Programme "offers students the opportunity to learn about British politics 'from the inside'". The ultimate goal of the Society is to 'strengthen parliamentary democracy and encourage greater public involvement in politics'; the Hansard Scholars Programme exists to further this aim by giving students access to internships at Parliament and closely related organisations, alongside lectures and supervised research.

The Hansard Scholars Programme offers undergraduate and postgraduate courses, which are both run in association with the London School of Economics. The undergraduate programme is run as a study abroad course for international students, with credit given by the students' home university towards their first degree, whilst the postgraduate course is aimed at postgraduates and young professionals who undertake research in their specialist areas. Many of the postgraduate students are funded by the Foreign & Commonwealth Office's Chevening scholarship scheme. Participants in both courses divide their time between internships and academic study.

Although the undergraduate programme consists mainly of US students, having been designed with the US education system in mind, the postgraduate programme attracts a very diverse mix of nationalities. At the time of the most recent BAC inspection, the Society had research scholars from the USA, EU and Commonwealth countries such as Uganda, New Zealand, Zimbabwe and Australia. Recent cohorts had included students from South America, Eastern Europe and Central Asia.

As sponsors under Tier 4 of the PBS (the Points Based System for assessing foreign nationals who wish to enter the UK), institutions such as the Hansard Society will now have certain duties. These will include monitoring student attendance and submitting figures to the Home Office, in order to make sure that immigration controls remain effective. It has now been confirmed that Tier 4 will open to migrant students in March 2009; in order to ensure that sponsor applications are processed by this time, the Home Office has requested that all applications are received no later than 2 February 2009. Beyond this date, applications will still be accepted, but there is no guarantee that they will be processed in time for the March 2009 policy implementation.

BBC INVESTIGATION INTO FAKE DEGREES

A FAKE ONLINE UNIVERSITY IN AMERICA has fooled thousands into buying phony academic qualifications, a recent BBC investigation found. Radio 5 Live's Donal MacIntyre programme revealed that nearly 10,000 fake credentials had been issued by the bogus St Regis University, including certificates in medicine and nuclear engineering.

Many of the 150 or so British graduates of St Regis had no idea that the degrees and university were anything but genuine, despite clear warning signs. In most cases students would simply have to submit coursework to obtain a St Regis qualification, there would be no tutor contact, and students could choose their graduation date or even backdate their degree. The report shows the worrying ease with which potential students can be conned into paying substantial sums of money for completely worthless qualifications. Alongside these organisations are the websites which cater for those dishonest students who wish to pay for fake degrees in order to fool potential employers. One website even attempts to justify the sale of fake qualifications by describing the fun you can have fooling friends and family with a 'novelty' degree and how it can be used as an 'amusing conversation piece'.

An earlier 2004 report on the Guardian website focused on a British website which openly advertised fake degrees from a number of top UK universities. The Guardian was able to obtain certificates from the website, including a bachelor of arts from Strathclyde University;

when the document was shown to the university's secretary, Dr Peter West, he was surprised by how 'real' the degree looked. Although the man behind the website was being investigated at the time of the report he was never charged and his website is still up and running.

Not only do these fake degrees threaten the integrity of genuine qualifications but they also pose a problem for employers. Although many employers ask to see an original document when checking qualifications, they may well be fooled by a convincing forgery, and should ensure that they make further checks if there is any doubt.

The consequences for those involved in fake degree scams can be far-reaching, regardless of whether the student was aware of the deception. Authorities in the United Arab Emirates recently moved to ban anyone from working in the UAE for life if they are caught using a fake certificate or degree. A bit closer to home, 50 students were recently expelled from Newcastle University after it was found that qualifications used to gain entry onto business studies courses at the university had been forged; the forgeries included English language qualifications and degree certificates from other universities. Newcastle University said that many of the students were the victims of bogus agents in China and the UK who submitted forged documents on their behalf. The university regretted that these students still had to be expelled in order "to protect the interests of hundreds of properly qualified students". The full article can be found at:
